INTERACTION REPORT

On the 29th of April, 2025, an insightful discussion on "Issues and Challenges of ITEP Programme" was held in the Head's Chamber, Department of Education, University of Kashmir. The Esteemed Guest Mr. Vikram Sahay, Principal Commissioner of Income Tax, Jammu & Kashmir, who also served five years in NCTE as an expert in the formulation and designing of teacher education programs in the country, graced the occasion with his visionary insights. Key Points Discussed

The main points covered during the expert discussion were;

- Professional Development of Teachers at the Foundational Level.

The interaction aimed to explore the ways for better collaboration between academic institutions and government agencies to ensure effective implementation of NEP-2020 in Jammu & Kashmir.
