**Item No:04**


To consider the request of Kaiser Ahmad Sofi, Research Scholar for abeyance/opt out as he has joined the state government as an employee.

At the outset the Head, Department of Education accorded warm welcome to the members of Departmental Research Committee. Then she informed them regarding the Agenda of the meeting. After threadbare discussion it was resolved as under:

**Item No:01**

To discuss the Revised synopses of 4 Integrated Ph.D. Scholars

- i) Resolved the case of Chesfeda Jan was sent to Department of Sociology, Social Work and Home Science and required information was collected. As per the information received from these Departments, it is evident that the proposed work is not repetition. Therefore, It is recommended that the synopses of the scholars be approved.
- ii) Gousia Jan, Lateefa Bashir & Naveeda Anjum were also discussed and it was resolved that with minor modification, the synopses of the scholars be also approved.

**Item No:02**

To consider the case of Hafizullah Qureshi for the Grant of Extension & the Re-registration for Ph.D programme.

Resolved that the scholar could not complete the Research Programme because of abrogation of article 370 & subsequent Covid-19. Moreover, the supervisor of scholar was also retired from the services and consequently, the scholar could not complete the programme within specific period of time. Therefore, it is recommended that the extension for the period of two years may be granted in favour of the scholar. It was also resolved that the re-registration shall be granted in favour of the scholar enable him to submit the thesis.

**Item No:03**

To consider the case of Mehraj ud din Bhat for Keeping his research programme in abeyance

It was also resolved that the full case history of the scholar may be compiled and sent to the competent authority for the perusal and necessary directions. And the research programme of the scholar may be kept in abeyance till the employer of the scholar allows him to complete the remaining residual period.

**Item No:04**

Resolved that the scholarship be granted as per the norms of the University. The Department shall prepare the interment of the eligible candidates for grant of the Departmental scholarship.
